In the matter of who pays for the date, in Mrs. Patterson's opinion, whoever asks the person out on the date should pay for the date.

- d. Pay attention to Red flags, when you see them, you should avoid them.
- e. Abuse is never okay, please call your local Regional Center.
- f. The first date should be fun, no pressure, just talk and get to know your date. Try not to overshare information.
- g. Nicole and her husband David share the same core values. They both believe that it is helpful to go to counseling before the getting married is great. It works if both parties our willing to try.
- h. Do a background check before you are engaged.
- i. It does not matter who makes the most money in the relationship.
- j. Try to make sure it is 50/50 with both parties our getting what they need. No relationship should be one-sided.

k. It is ok to put yourself out there and date when your ready.

- a. Mr. Garrett Ackerman presented on Meeting on his program called Rumi, which is a service that pairs adults with developmental disabilities another adult with similar interest. The main location and office is in Minnesota.
- b. The roommates which are also direct support staff, help with the roommates, and with tasks to make sure the roommates pays their bills on time.
- c. Rumi has one success story that they were able to move an individual into another apartment that individual wanted in a different location.
