- Welcome/ Introductions/Approval of November 2023 Meeting Minutes (voting item)
 - Sherry Johnson called roll call.
 - Quorum was not established.
 - At the start of the meeting only 4 committee members were present for roll call. Mrs. Johnson will keep track of committee members as they come in.
- SDP Updates
 - Cynthia Rivera introduced guest speaker Cherylle Mallinson SCLARC Director of Community Services
 - Self Directed Support Service Code 099

This presentation is to provide information to individuals, family and the community related to nonvendored service code 024 vs service code 099.

Service Code 024 is a Purchase Reimbursement for the initial Person Centered Plan.

2/13/2019: DDS Directive regional centers can purchase PCPs from vendored or nonvendored providers (requested by participants). Payments to nonvendors are made as 024.

9/3/2019: DDS Directive additional clarification for previous directive. Payments can be made directly to providers. Service Code 024 does not require vendorization as a person centered planning services provider. Limited to initial PCP.

10/30/2020: DDS Directive further clarification when purchasing initial PCP service code 024 can include payments to independent facilitators.

7/28/2022: DDS Directive

Option A – reimbursement for initial PCP up to \$2,500 available until 12/31/2023.

Option B – Effective 2/1/2024 the only option for initial PCP is service code 099 which reduces the payment amount to \$1,000.

6/30/2023: DDS Directive

Option A – Effective 1/1/2024 this option will no longer be available

Option B – Effective 1/1/2024 this will be the only option available

12/22/2023: DDS Directive

Option A - For initial PCP and transition support families can select; SC 024 (purchase reimbursement) of up to \$2,500 or vendored provider of PCP services.

Option B – Separates initial PCP and pre-enrollment transition supports. For initial PCP; SC 024 (purchase reimbursement) up \$1,000 or SC 099 (vendored provider) up to \$1,000

Pre-enrollment transition support is offered via and is separate from PCP funding;

Service Coordinators, Regional Centers, SDPLAC, and Participant Choice Specialists. Any additional support is available under SC 099.

Providers must submit a standardized vendorization packet by 2/29/2024 or else they will be limited to only servicing the clients they already have, They will not be able to grow their client base.

Q&A:

Sherry Johnson: If a service provider is vendorized at Harbor (Regional Center) will they have to vendorize at SCLARC?

Cherylle Mallinson: No, as long as they have been vendorized at Harbor. The only thing that would change is the rate. But we would need to get their information. The state is working on a more uniform vendorization process. The service providers would need to be requested by clients of SCLARC.

Veronic Moser: How many IFs have been vendorized under 099?

Mallinson: Unknown, those who have gone through the process have not been official Ifs.

Octavia Askew: Excellence Rehabilitation Program has been providing services under 099 for SCLARC.

Mallinson: The agency is an agency but the IF as an individual who has gone through the 099 vendorization process is different.

• Yvette Torres from Acumen Fiscal Agent

- Financial Management Services are a requirement for SDP
- 3 FMS types
 - Bill Payer
 - Co-employer
 - Sole Employer

Acumen only offers Bill Payer and Sole Employer.

Common misconception is that as a Sole Employer the participant would have to take care of payroll and other employer related duties but this not the case. The FMS assists with processing payroll. The FMS purchases approved goods and services listed on the participant's spending plan. If it is not listed on the spending plan then the FMS will refer you back to the regional center to get an updated spending plan.

Provide general overview of our process including payment methods

Enrollment packet - can be a lengthy process, need to allow ample time

Traditional services need to end before transitioning into SDP and if your enrollment is not complete you may be left without any services.

Santiago: Under Sole Employer do you need to get the insurance, worker's compensation, liability, etc.. yourself? Can the FMS help us with this?

Yvette: At Acumen worker's compensation is included in the Employer Burden. Any additional insurances would be the participant's responsibility.

- Lourdes Gomez: Shows concern as an IF who has approached an SC for an individual who wants to transition from a day program to a tailored day program but found that the SC doesn't know what that is. SCLARC does have a presentation on the website with that information so it is concerning that the SC is unaware of the service. Asks if SCLARC can consider giving a presentation to their SCs.
- Kim Sinclair Executive Director for Autism Society of Los Angeles: Update the training for Advanced Independent Facilitators is in full swing.
- Cynthia Rivera In collaboration with Autism Society of Los Angeles, a customized four week module has been created for the SCLARC catchment area.

- 12/26/2023 DDS Directive: Billing Requirements for Local Businesses or Community Resource
 - A local business or community resource is defined as an entity not vendored by a regional center that provides services to individuals with and without developmental disabilities
 - FMS provider will work with participant on the required documentation. For example, a membership contract at the local gym
 - Payments for these services will be made according to the providers' payment process. For example, if a subscription is payable at the beginning of the month then the FMS should adjust their payment schedule to purchase these services.

• 12/22/2023 DDS Directive: FMS Transition Supports

- Transition Supports shall be paid to FMS providers in 3 scenarios
 - Initial enrollment of SDP participant
 - Participant transfer from one FMS to another (to be paid by receiving FMS)
 - A participant's transfer from one regional center to another.
