 - o FMS: The trailer bill SB 188 which was amended welfare and institutional code section 6468 5.8 removing the requirement that costs a financial management service, the FMS will be paid by the participant out of the participants individual budget the statutory change was effective on July 1, 2022.
 - o SMS Provider: Effective July 1, 2022 the cost of the SMS provider, where we paid by regional Center outside of the individuals budget. SCLARC is currently developing the process for implementing this change individuals and families currently receiving the service under Self-Determination.

• The public had questions in regards to the independent facilitators and how the independent facilitators are being paid now. Cynthia answered by stating they will be paid by the participant's budget. But the public requested if SCLARC could continue in assisting the parents and SCLARC agreed.
