Project #5 (CRDP)

Supported Living Services (SLS) – Forensics SLS provided one to one to forensically and/or Difficult to serve individuals with intellectual disabilities and mental health issues. There are multiple cases who are difficult to serve and cannot reside in a residential facility setting due to their behaviors, as manifested by them making suicidal/self-injurious statements, refusing services, abusing illegal substance, making false allegations, etc. SLS provider and staff must be equipped with a behavioral component and RBT background as well as trained professionals to handle behaviors without interruption to the services. An ideal vendor can provide augmented services or hire professionals as DSP to manage and provide services to the individuals. SLS forensics may be composed of social workers, therapists, counselors, and behavioral technicians that can support and manage the individuals in need - help identify triggers and create a structured setting to reduce the triggers and identify what other needs the individual may have. The agency must connect the individual with mental health supports if there is a need for long-term counseling.

Project #6 (CRDP) Project #6 (CRDP)

Four (4) Children/Adolescent Residential Facilities. Behaviors of AWOL, severe physical aggression towards others, property destruction, noncompliance with rules in the home and school, sexual misconduct with peers, dual diagnosed with mental health conditions (depression, anxiety and suicidal ideations). Dual diagnosed with mental health conditions and prescribed psychotropic medications. History of behaviors including AWOL and Severe Physical Aggression (i.e. hits young children & adults), and moderate to severe Self Injurious Behavior (i.e. requires helmet and mittens; thus, need a waiver from CCL). Some children may also have gender identity disorder, cruelty to animals, Substance Abuse, Gang Affiliation, allegations of molestation towards other children, history of trauma and/ or sex trafficking. May be a ward of the court or judicially involved with dual agency supervision from DCFS and /or Probation. This is also proposed in FY2022-24. This continues to be a need for SCLARC catchment area.
