South Central Los Angeles Regional Center's Plan for Use of Funding to Support Compliance with the Home and Community-Based Services (HCBS) Final Rule

SCLARC has developed the following plan in collaboration with our Vendor Advisory Committee in regard to how funds provided by the Department of Developmental Services (DDS) will be spent and utilized to support compliance with the HCBS Final Rule. The total amount of funds available is **\$733,186.00** for Fiscal Year 2024-25.

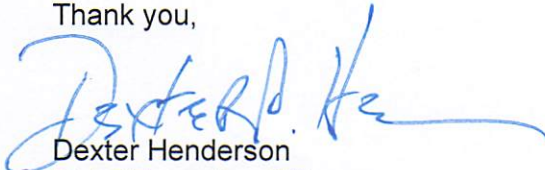

1. We will offer training for service provider DSPs on how to properly document and incorporate HCBS language into their notes. We will allocate funds to develop tools that support the continuous monitoring of service providers' HCBS compliance, including creating forms for staff to document and track compliance on an ongoing basis. We will hire a contractor to develop a sustainable HCBS training portal for QA staff and Service Coordinators, enabling staff to log in and complete ongoing HCBS compliance training.	Meraki	\$200,000
