### 3. Self-Determination Program (SDP) Updates

- Overview of the SDP Team and Roles
- > Enrollment Pathways & Timelines
- Enrollment Totals: 174 total participants (94 adults, 80 children)
- Budget Data:
  - o \$13M in total authorizations
  - o Average individual budget: \$98K
  - o Adults average: \$118K | Children average: \$76K
- Budget Utilization Rates:
  - o Year 1: 68%
  - o Year 2: 75%
  - o Year 3: 80%
  - Years 4 & 5 lower due to unreported expenditures
- FMS Providers: 11 in use, top 3: GT Independence, Acumen, Aviana
- Challenges and Opportunities for Improvement:
  - o Issues with budget development and spending plans
  - o Need for more training and alignment with Independent Facilitators
  - o Concerns with provider availability and system delays

- Committee discussion emphasized the importance of individualized services and potential cost comparisons with traditional services.
